RESOLUTION NO. 13

"WHEREAS, in a letter to the General Manager, National Water-
works and Sewerage Authority, Manila, the Honorable City Mayor of
Ormoc stressed the advantages of a gravity waterworks system for
Barrio Cabulihan, this city, instead of the proposed artesian well
for the same barrio;

"WHEREAS, in a series of indorsements subsequent to said
letter waterworks authorities maintained that the construction of
a separate waterworks system for B. Cabulihan is more preferable
than extending the present waterworks at Hibunagon to the former;

"WHEREAS, Republic Act 1613 (page 958-A) has set aside the
amount of P40,000 for the construction of a separate system for
Barrio Cabulihan, half of this amount, according to said Act,
will be released during the fiscal year 1957-58;

"WHEREAS, it is most likely that a considerable portion of
this amount will have to be transferred to other projects in
the country if Cabulihan will have an extension only from an
existing system instead of having one that is totally indepen-
dent and separate;


"NOW, THEREFORE, the Board, on motion of Councilor Ifiaki
Larrazabal, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to request as
this Body hereby requests the General Manager, National Water-
works and Sewerage Authority, Manila, to release or cause or
facilitate the early release of the amount allocated for the
construction of a waterworks system for Barrio Cabulihan, Ormoc
City, as provided for in Republic Act 1613;

"RESOLVED FINALLY, to furnish copies of this Resolution
each to the General Manager, National Waterworks And Sewerage
Authority, Manila; the Waterworks Supervisor, Ormoc City; the
Honorable City Mayor, the City Treasurer and the City Auditor,
all of Ormoc City.

"CARRIED UNANIMOUSLY."
