## RESOLUTION NO. 13

WHEREAS, in a letter to the Geneval Manager, National Waterworks and Sewerage Authority, Manila, the honorable City Mayor of Ormoc stressed the advantages of a gravity water orks system for Barrio Cabulihan, this city, instead of the proposed artesian well for the same barrio;

"MHEREAL, in a series of indorsements subsequent to said letter waterwick authorities maintained that the construction of a separate vat tworks system for Bo. Cabulihan is more preferable than extending the present waterworks at Hibunaon to the former;

WHEREAL, Republic Act 1613 (page 958-A) has set aside the abount of P40,000 for the construction of a separate system for Barrio Chulihah, half of this amount, according to said Act, will be released during the fiscal year 1957-58;

"Manuas, it is most likely that a considerable portion of this amount will have to be transferred to other projects in the country if Cabulihan will have an extension only from an esting system instead of having one that is totally independent and separate;

"NOW, THEREFORE, the Board, on motion of Councilor Inaki Larrazabal, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to request as this Body hereby requests the General Manager, National Waterworks and Suwerage Authority, Manila, to release or cause or facilitate the early release of the amount allocated for the construction of a waterworks system for Barrio Cabulihan, Ormoc City, as provided for in Republic Act 1613;

\*RESOLVED FINALLY, to furnish copies of this Resolution each to the General Manager, National Waterworks And Sewerage Authority, Manila; the Wateroworks Sypervisor, Ormoc City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
