RESOLUTION NO. 175

"WHEREAS, on manifestation of Councilor Emilio C. Penserga to amend Resolution No. 175, series of 1956 in such a manner as to conform with the letter of the Assistant Civil Engineer, Ormoc City, dated January 5, 1957, which is quoted verbatim hereunder:

"In view of the representation to this Office of Mr. Vicente Banzon in behalf of Mrs. Anaclita Carrillo's claim for Road Right-of-Way, I have the honor to inform you that Resolution Number 175 passed in your session on September 22, 1956 be amended in view of the fact that the JJ funds of this Office is not subject to budgetary action of that body.

"It is therefore suggested that that body shall appropriate the amount from the local roads and bridge funds not otherwise appropriated to pay the claim as represented by Mr. Vicente Banzon.

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P200.00 from out of the Roads and Bridge Fund (J-Funds) not otherwise appropriated, to be made available for the payment of a portion of the lot of Mrs. Anacleta Carrillo used and occupied by the city for the widening of Bonifacio Street;"

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and Mrs. Anacleta Carrillo, all of Ormoc City.

"CARRIED UNANIMOUSLY."


