RESOLUTION NO. 18

"WHEREAS, Councilor Teotimo Ocubillo manifested before the Body that in the morning of February 1st, 1957, while he was in the Office of the City Engineer, he heard - not only he, but many people around - Engineer Fernandez lambasting City Engineer Trinchera in loud and thunderous voice;

"WHEREAS, this Board learned that the incident occurred as an aftermath of a memorandum issued by City Engineer Trinchera to Asst. Engineer Fernandez, which the latter refused to execute;

"WHEREAS, it is very humiliating of a chief of office to be lambasted by a subordinate and refused of his orders in front of so many people;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request the City Attorney to investigate the aforementioned incident in the Office of the City Engineer, and to file corresponding action should he find that circumstances warrants the filing of a court action against Engineer Adventor Fernandez;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Attorney and Engineer Trinchera, all of Ormoc City.

"CARRIED UNANIMOUSLY."
