RESOLUTION NO. 20

"WHEREAS, it has been brought to the attention of this Body that yesterday, February 1, Assistant Civil Engineer Adventor Fernandez, in no uncertain terms refused to follow a memorandum order issued by the City Engineer, Godofredo Trinchera regarding the employment of certain people recommended by members of this Body;

"WHEREAS, in his refusal to said memorandum order he lambasted his superior, City Engineer Trinchera in terms that do not book a subordinate official;

"WHEREAS, the manner and attitude he has shown in his refusal of the memorandum order caused great embarrassment and humiliation to his superior City Engineer, because he stated his refusal in a loud and belligerent manner in front of many visitors and employees of the City Engineer's office, including City Councilor Teotimo Ocubillo, who was then visiting the City Engineer;

"WHEREAS, because in his tirade against the City Engineer he mentioned this Body by telling the City Engineer that he should not be dictated upon by politicians and admit political proteges of this Body;

"WHEREAS, in other incidents previous to this last incident the Assistant Civil Engineer, Adventor Fernandez, had shown disrespect towards the present administration to the extent of practicing nepotism by the appointment of his brother as driver of a city engineering truck and by flaunting his authority as said Assistant Civil Engineer by using the premises of a shop building for his private residence without as much as taking leave or permission of the other city officials;

"WHEREAS, his past and present action bespeaks of a man whose intent is on causing disharmony among the officials of this city;

"WHEREAS, Assistant Civil Engineer Adventor Fernandez is a persona non grata to the present administration of Ormoc City;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to report all these actions of Assistant Civil Engineer Adventor Fernandez of Ormoc City to his direct superiors in the Department of Public Works and Communications, with the information that Assistant Civil Engineer Adventor Fernandez is now persona non grata to the present administration of Ormoc City and with the recommendation that he be removed forthwith from this city, in order that harmony again prevail in the official circles of Ormoc City with that of the Engineering Department;



"PASSED UNANIMOUSLY."


