RESOLUTION NO. 22

"WHEREAS, it has come to the knowledge of this Body that there is approved, a plan to construct an artesian well in Bo. Patag, Ormoc City;

"WHEREAS, the construction of the proposed artesian well in Barrio Patag, this city, will give an oversupply of water to residents thereof, and deprive other barrios who are in dire need of water facilities, the fact that there is at present, an existing water supply in Barrio Patag;

"WHEREAS, on suggestion of the Presiding Officer, the Honorable City Mayor, to request the National Waterworks and Sewerage Authority, Manila, to transfer the proposed artesian well in Barrio Patag to Barrio Borok, Ormoc City;


"NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to request the National Waterworks and Sewerage Authority, Manila, to transfer the proposed artesian well for Barrio Patag, to Barrio Borok, this city, for the reason that there is already at present, a water supply for the people of Barrio Patag;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the General Manager, NWSA, Manila; the Regional Field Superintendent, NWSA, P.O. Box 267, Cebu City; the District Waterworks Engineer, Tacloban City; the Waterworks Supervisor, Ormoc City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.


