## RESOLUTION NO. 25

WHEREAS, Resolution No. 350 passed by the Municipal Board of the City of Dumaguete on January 11, 1957 requested Congressmen Lorenzo G. Teves and Lamberto L. Macias of Negros Criental to present a bill during this session of Congress of the Philippines amending Section 2 of Republic Act No. 1612 amending Section 180 of Commonwealth Act No. 466 Pixing taxes payable annually, in such a manner as to make payable quarterly or sani-annually;

"WHENAS, this Board humbly believes that the purpose of the Municipal Board of the City of Dumaguete in passing said Resolution No. 3.0 is to uphole the spirit behind the Retail Trade Law which have been designed to promote and protect Filipinos engaged in retail trade

"WHENE'S, business of little capital owned by Filipinos, like the market vendors and other small retail trade, are the ones most affected because they could hardly pay in full the fixed annual tax to be paid on or before the twentieth of January of each year and maybbe constrained to close their business;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere to, the embodiments of Resolution No. 350 passed by the Municipal Board of the City of Dumaguete on January 11, 1957, and to request Congressman Domingo Veloso of the Second District of Leyte and all the other Congressmen of the Province of Leyte, to jointly pass a bill during this session of Congress, amending Section 2 of Republic Act No. 1612, such that the annual tax fixed therein be made payable quarterly or semi-annually;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the five Congressmen of the Province of Leyte, all in Manila; the Leyte Provincial Board, Tacloban City; the Speaker, House of Representatives, Manila; the President of the Senate, Manila; the Municipal Board, City of Dumaguete; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"GARRIED UNANIMOUSLY."
