RESOLUTION No. 26

"WHEREAS, in the fiscal budget of Ormoc City for the year 1953-1954 salaries of several positions were raised effective October 17, 1953, among those of which were the members of the police force;

"WHEREAS, all the members of the police force whose salaries were raised were terminated in February, 1954 by Acting Vice Mayor Roberto Almaden, and many of them were unable to collect their salary differentials;

"WHEREAS, several representations have been made by these policemen to this Board requesting an appropriation to pay for their salary differentials; and

"WHEREAS, considering that some of these policemen are already out of the service and that they/are presently financially hard up, and considering further that this is a mandatory obligation of the city to these policemen;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilors Emilio C. Penserga and Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to revert from out of the salary savings of the police department, the amount of ₱600 to be made available for the payment of the salary difference of:




