"WHEREAS, in the fiscal burget of trace City for the year 1953-1954 salaries of several positions were raised effective October 17, 1953, among those of which were the members of the police force;

"WHEREAS, all the manners of the police force whose salaries were raised were terminated in February, 1954 by Acting Vice Mayor Roberto Almaden, and many of them were unable to collect their salary differentials;

"WhiteAS, several representations have been made by these policemen to this Board requesting an appropriation bo pay for their salary dell'erentials; and
