RESOLUTION NO. 27

"WHEREAS, this Board passed Resolution No. 27, s. 1956, requesting the Bureau of Coast and Geodetic Survey to transfer the Lighthouse at Ormoc City from its present location to another site, for the reason that it is an obstruction to traffic, the fact that it occupies almost half of the width of the street leading to the pier;

"WHEREAS, in a letter to this Board dated February 19, 1957, the Acting Director, Bureau of Coast and Geodetic Survey and Acting Chairman of the Lighthouse Board, informed that in a meeting held on February 1, 1957, the Lighthouse Board passed a resolution requesting the Bureau of Public Works to locate a suitable place within the area comprising the present site of the Ormoc Light wherein the same could be transferred;


"NOW, THEREFORE, the Board, on motion of Councilor Jorge P. Tan, Jr., seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the Director of Public Works, Manila, to implement the resolution of the Lighthouse Board requesting the Bureau of Public Works to locate a suitable place wherein the present Ormoc Light could be transferred;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Secretary of Public Works and Communications, Manila; the Director of Public Works, Manila; the Director, Bureau of Coasts and Geodetic Survey, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


