RESOLUTION NO. 28

"WHEREAS, in the current fiscal budget of Ormoc City, there is an item of ₱10,000 under the office of the City Mayor which is intended for the construction of a gymnasium and social hall;

"WHEREAS, the said ₱10,000 as appropriated in the current fiscal budget is far less than the estimated cost of the gymnasium and social hall project, so that this Body has thought of spending said amount for the purchase of a car for the City Mayor, instead of proceeding with the construction project without sufficient funds;

"WHEREAS, this Body deems it most advantageous to the interest of the city government to provide the City Mayor with a car in order to facilitate the implementation of administration policies and visiting and inspecting barrios and people living in rural areas;


"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, ~~to~~ to transfer the appropriation of ₱10,000 embodied or incorporated in the current fiscal budget under Contingent Expenses for the Office of the City Mayor for the construction of a gymnasium and social hall, to purchase of a car for the City Mayor;



"CARRIED UNANIMOUSLY."


