RESOLUTION NO. 31-A

"WHEREAS, this Board passed Resolution No. 103, series of 1956, flatly rejecting the petition of Marcelo Diaz Bandalan, et al, requesting among other things to purchase the lots in Canlampag District, this city, for the reason that the city government needs the same for future public improvements;

"WHEREAS, in a letter to this Board dated January 31, 1957 the Director of Lands, Manila requested that a resolution specifying the desired purpose for the reservation of said lots, be passed; and

"WHEREAS, Resolution No. 103, series of 1956 of this Board clearly specifies that the land in Canlampag District is reserved as City Hall site and for other future public improvements which the city may undertake;


"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to reiterate the contents of Resolution No. 103, series of 1956 and do hereby inform the Director of Lands, Manila, that the land in Canlampag District is reserved as City Hall site, boulevard and such other improvements as the city may undertake in the future.


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Lands, Manila; the District Land Officer, Tacloban City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


