RESOLUTION NO. 31

"WHEREAS, the Municipal Government of Ormoc owns some lots within the poblacion, now being utilized by the city government, such lots as Lot Nos. 20, 23 and 17 of the Ormoc Cadastre ;

"WHEREAS, Lot Nos. 610, 37 and 827 of the same Ormoc Cadastre are designated as Public Lands, which, as of the present is reserved by the City Government as city hall site and for such other public improvements which may be undertaken in the future;

"WHEREAS, it has come to the knowledge of this Board that these lots mentioned above have not as yet been titled in favor of the city government of Ormoc despite the fact that the same have been occupied and improved by the city government since the existence of the former municipal government of Ormoc;


"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to work for the acquisition of titles in favor of the city government of Ormoc of the lots mentioned above;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the City Attorney, the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


