WBE IT RESOLVED, as it is hereby resolved, to concur in and adhere to the embodiments of Resolution No. 72, series of 1957 of the Municipality of Batangas, Batangas, and request further 33 this Body hereby requests, Congress, to repeal said provision of the Revised Election Code and allow elective provincial, municipal, or city officials to run for any elective office in our government without forfeiting their offices from the time they file their certificates of candidacy
