RESOLUTION NO. 33

"WHEREAS, the Municipal Council of Batangas, Batangas, passed Resolution No. 72 on February 2, 1957, requesting Congress to repeal Section 27 of the Revised Election Code in such a manner as to allow elective provincial, municipal, or city officials to run for any elective office in our government without forfeiting their offices from the time they file their certificates of candidacy;

"WHEREAS, this Body is of the opinion that this particular provision of law as embraced in Sec. 27 of the Revised Election Code is unfair and unjustly discriminative against elective provincial, municipal, or city officials who constitute the majority of our government's officialdom;


"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Guillermo T. Parrilla,

WBE IT RESOLVED, as it is hereby resolved, to concur in and adhere to the embodiments of Resolution No. 72, series of 1957 of the Municipality of Batangas, Batangas, and request further as this Body hereby requests, Congress, to repeal said provision of the Revised Election Code and allow elective provincial, municipal, or city officials to run for any elective office in our government without forfeiting their offices from the time they file their certificates of candidacy;




