RESOLUTION NO. 34

"WHEREAS, the Provincial Board of Tarlac passed Resolution No. 235, s. 1957 reiterating their request to Congress to approve in its present Congressional Session, the entire repeal of Republic Act No. 1383 which created the National Waterworks and Sewerage Authority;

"WHEREAS, the same Provincial Board of Tarlac passed Resolution No. 294 on March 3, 1956, protesting against the implementation of said Republic Act No. 1383, it being highly oppressive, if not altogether unconstitutional and requested Congress for its repeal;

"WHEREAS, this Board joining in the plight with other Provincial and Municipal Boards, City and Municipal Councils in protesting with due respect the implementation of Republic Act No. 1383, passed Resolution No. 86 on April 14, 1956 concurring in and adhering to the embodiments of Resolution No. 294, s. 1956 of the Provincial Board of Tarlac;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere to as this Body hereby concurs in and adheres to, the embodiments of Resolution No. 235, current series, of the Provincial Board of Tarlac, and to request further as this Body hereby requests, Congress to approve in its present session, the entire repeal of Republic Act No. 1383.

"RESOLVED FINALLY, to furnish copies of this Resolution each the Speaker and the Secretary, House of Representatives, Manila; the President and the Secretary of the Senate, Manila; the President of the Philippines, Malacañang, Manila; each of the five congressmen of the Province of Leyte, all in Manila; the Provincial Board, Tarlac, Tarlac; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
