RESOLUTION NO. 35

"WHEREAS, the Barrio people of Catayum, this city, addressed a petition to this Board soliciting help and asking this Board to make representations to the National Waterworks and Sewerage Authority to have the artesian well in Catayum dug deeper;

"WHEREAS, according to same petition the water coming from their artesian well during rainy days is brownish, which, as analyzed by the Water Analysis Station in Cebu City, is unsafe for drinking;

"WHEREAS, this Board pretty well knows that except the artesian well now subject of the petition, the Barrio people of Catayum has no other source of water supply readily accessible by a majority of the barrio populace;

"WHEREAS, barrio Catayum is a community stretched on both sides along the national highway extending over a kilometer, thus the artesian well which is located at the center cannot possibly serve those living from either farther end without sacrificing to walk about .7 of a kilometer;

"WHEREAS, the same petition of Catayum informs that there are barrio residents who have signified their willingness to donate a lot wherein additional wells can be dug;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to indorse the aforementioned petition of the residents of barrio Catayum, this city, to Mr. Felipe Victoria, NWSA Supervising Well Driller at Ormoc City, and to request him further to have the artesian well thereat dug deeper, and possibly, construct or dig two more wells as requested in said petition;

"RESOLVED FINALLY, to furnish copies of this Resolution each to Mr. Felipe Victoria, Supvg. Well Driller, NWSA, Ormoc City; the Barrio Lieutenant, Catayum, the Honorable City Mayor, the City Treasurer, the City Auditor and the Waterworks Supervisor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
