Aviles St. to the corner of Lopez Jaena St., and that the same be designated as a temporary market place/site for those stall holders affected by the forthmening construction;

"RESOLVED FURTHER, that the transfer of these stall holders to the closed portion of Rizal St. be supervised by the Market Superintendent in order to avoid unnecessary congestion and blocking of those stores along the same street;

"RESOLVED FURTHERMORE, that this Resolution take effect as of the date of approval by the City Mayor of Ormoc;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the Chief of Police, the City Health Officer and the Market Superintendent, all of Ormoc City.
