RESOLUTION NO. 38

"WHEREAS, this Board passed Resolution No. 193, series of 1956, reverting P90.00 from out of the salary savings of the City Health Department for the purchase of a Mercurial Blood apparatus and a Stethoscope for use of said department;

"WHEREAS, in view of the fact that there is no salary savings in the City Health Department, said Resolution No. 193 could not be implemented and no purchase has been made therefor;

"WHEREAS, the City of Ormoc is in receipt of her share from the Philippine Charity Sweepstakes draw held on October 28, 1956 in the amount of P92.48 as covered by Check No. PC-02302;

"WHEREAS, as provided by law, this share may be allotted by the Municipal Board for maintenance of city health, social welfare and charitable work based upon the recommendation of the chief of the health department;

"WHEREAS, the City Health Officer, in a 2nd indorsement dated March 6, 1957 recommended that this amount of P92.48 as covered by the check mentioned above, be applied for the purchase of one blood pressure apparatus and one stethoscope for the public dispensary, inasmuch as these equipments had not been purchased from the appropriations carried on Resolution No. 193, s. 1956, for the reason already stated in the second paragraph hereof;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to amend Resolution No. 193, s. 1956, to read as follows:

"BE IT RESOLVED, as it is hereby resolved, to revert the amount of P92.48, Ormoc City's share from the Philippine Charity Sweepstakes draw on October 28, 1956, covered by Check No. PC-02302, for the purchase of a Mercurial Blood Pressure apparatus and a Stethoscope for use in the City Health Department;"

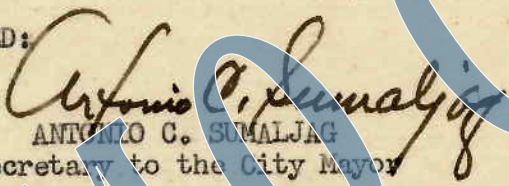
