RESOLUTION NO. 39

"WHEREAS, Ormoc City is in receipt of her share from the Philippine Charity Sweepstakes draw held on December 16, 1956 in the amount of P180.22 as covered by Check No. PC-02460;

"WHEREAS, as provided by law, this share may be allotted by the Municipal Board for maintenance of city health, social welfare and charitable work based upon the recommendation of the chief of the health department;

"WHEREAS, the City Health Officer, Ormoc City, in a 2nd indorsement dated March 6, 1957 recommended that this amount of P180.22 covered by the check mentioned above, be used for the purchase of medicines and supplies for the public dispensary because according to the same indorsement the appropriation for medical supplies and medicines are already exhausted;

"WHEREAS, it has been brought to the attention of this Board that the dental attendant in the city health department had not been paid of her salaries for months now, as the sweepstakes share allotted for her salaries had been consumed; and

"WHEREAS, considering that the city health department still carries in stock some medicines, this Board deems it more urgent to pay the salaries of the dental attendant with the amount mentioned above than to apply the same for the purchase of medicines;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the share of Ormoc City from the Philippine Charity Sweepstakes draw on December 16, 1956 in the amount of P180.22 covered by Check No. PC-02460, for the salary of the dental attendant in the Office of the City Health Officer, Ormoc City;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor & the City Health Officer, all of Ormoc City.
