"RE IT RESOLVED, as it is hereby resolved, to appropriate the share of Ormoc City from the Philippine Charity Sweepstakes draw on December 16, 1956 in the amount of P180.22 covered by Check No. PC-02460, for the salary of the dental attendant in the Office of the City Health Officer, Ormoc City;
