RESOLUTION NO. 40

"WHEREAS, the Municipal Board of the City of Cagayan de Oro passed Resolution No. 48 during its ordinary session on February 13, 1957 requesting the President of the Senate and the Speaker of the House of Representatives, through Senator Emmanuel Pelaez and Congressman Ignacio S. Cruz, to amend Section 2 of Republic Act No. 1612 in such a manner that the fixed annual tax be paid quarterly or semi-annually;

"WHEREAS, this Board passed Resolution No. 25 in its regular session on February 16, 1957 concurring Resolution No. 350 of the Municipal Board of the City of Dumaguete treating on the same subject matter;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere to as this Body hereby concurs in and adheres to, the embodiments of Resolution No. 48, current series, of the Municipal Board of Cagayan de Oro City, and to request Congressman Domingo Veloso of the Second District of Leyte and all the other congressmen of the province of Leyte, to jointly pass a bill during this session of Congress, amending Section 2 of Republic Act 1612, such that the annual tax fixed therein be made payable quarterly or semi-annually;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the five congressmen of the Province of Leyte, all in Manila; the President and the Secretary of the Senate, Manila; the Speaker and the Secretary of the House of Representatives, Manila; the Municipal Board, City of Cagayan de Oro; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
