RESOLUTION NO. 41

"WHEREAS, the Provincial Board of Surigao passed Resolution No. 363 in a special meeting held on February 16, 1957 asking all Provincial Boards and City Councils of the Philippines to pass a resolution appealing to President Ramon Magsaysay and to all the Members of Congress that this local autonomy bill presented in Congress be pushed through and approved by this session of Congress;

"WHEREAS, the embodiments of said Resolution No. 363 of the Provincial Board of Surigao are all appealing and agreeable to this Board, considering that in a democratic country local governments ought to be given as much as possible complete and absolute autonomy in running the affairs of their respective local governments;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere to, as this Body hereby concurs in and adheres to the embodiments of Resolution No. 363, of the Provincial Board of Surigao, and to request further President Ramon Magsaysay and all members of Congress that this local autonomy bill presented in Congress be approved during this session of Congress;

"RESOLVED FINALLY, to furnish copies of this Resolution each to President Ramon Magsaysay, Malacañang, Manila; the Secretary and the Speaker, House of Representatives, Manila; the President and the Secretary of the Senate, Manila; each of the five congressmen of the province of Leyte, all in Manila; the City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
