RESOLUTION NO. 42

"WHEREAS, by virtue of Resolution No. 114, s. 1951, of the Municipal Board, this city, Mrs. Eduarda Tomada, Contractor for the Prisoners' subsistence, accumulated a collectible difference of P650.70, this amount having been the subject of Resolution No. 58, s. 1953 of same Municipal Board;

"WHEREAS, this difference in the amount of P560.70 has been a result of the increase of the daily subsistence of each prisoner in the city jail of Ormoc City, from P.60 to P.80, as authorized in said Resolution No. 114, s. 1951;

"WHEREAS, in view of the precarious financial condition of the city government in 1953 when the Municipal Board authorized the payment of said difference, Mrs. Eduarda Tomada was not able to collect said amount;

"WHEREAS, Mrs. Eduarda Tomada is again making representations with this Board so that she may be able to collect this difference which the city is obligated to pay; and

"WHEREAS, the Asst. City Treasurer, in a note to the Secretary of this Board signified his willingness to pay this amount upon the passage of a resolution authorizing him to pay the same, chargeable against the current fund;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Esteban C. Conejos;

"BE IT RESOLVED, as it is hereby resolved, to appropriate from out of any funds existing in the city treasury not otherwise appropriated, the amount of P650.70 to be made available for the payment of the difference of the daily subsistence to prisoners, in favor of Mrs. Eduarda Tomada;

"RESOLVED FURTHER, to authorize the City Treasurer, Ormoc City, to pay Mrs. Eduarda Tomada the amount carried hereon;


"RESOLVED FURTHERMORE, to repeal as it is hereby repealed, Resolution No. 58, s. 1953; and


