RESOLUTION NO. 44

"WHEREAS, an artesian well has been dug under contract with the NWSA in Barrio Borec, Ormoc City;

"WHEREAS, the contractors digging said well in Borec has abandoned the work because they hit a big stone and that their equipments can not go through the stone;

"WHEREAS, in the interest of people of barrio Borec and others who may have the benefit of using the facilities of an artesian well, Councilor Samson manifested to request the National Waterworks and Sewerage Authority to take over the digging of the well on Borec, Ormoc City, inasmuch as the private contractor who started to dig said well has abandoned the work after they hit a big stone;

"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Esteban C. Conejos;

"BE IT RESOLVED, as it is hereby resolved, to request the National Waterworks & Sewerage Authority, Manila, to take over the digging of the well in barrio Borec, Ormoc City, for the reasons stated above; and

"RESOLVED FURTHER, to request also the NWSA, Manila, to take with them their power rig which might be used to push through stones the digging of wells;


"RESOLVED FINALLY, to furnish copies of this Resolution each the Manager, National Waterworks & Sewerage Authority, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


