The undersigned was informed by the City Treasurer's Office that
the appropriation for Office Supplies, materials and books in
the Municipal Court has been overdrawn in the excess amount of
P84.57. On the other hand however, this office has an unexpended
funds available for the following contingent expenses:

P 70.00 communications
84.00 emergency repairs of office equipments etc.
200.00 traveling expenses

In order that the above-mentioned overdraft for office supplies
etc. be covered, it is requested that part of funds (unexpended)
for the above itemization be reverted to and for the other needs
of this office, to wit:

P 25.00 from communications and
60.00 from emergency repairs of office equipments etc.
P 85.00

P 200.00 from traveling expenses
P 285.00 Total

The total amount of P285.00 be reverted to and for Office Supplies,
Materials and Books; Office Equipments and Repairs, book binding


"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Emilio G. Pensaraga;

"CARRIED UNANIMOUSLY."


