RESOLUTION No. 47

"WHEREAS, this Board, in its regular session on March 9, 1957 passed Resolution No. 37, c.s. closing Rizal St. from the corner at C. Aviles to the Corner at Lopez Jaena to vehicular traffic in order to allow stall holders affected by the forthcoming construction of public market buildings to continue their business and so as not to affect government revenues coming from market collections;

"WHEREAS, this Board has found an adequate site wherein which these stall holders can be transferred without sacrificing traffic at Rizal Street; and

"WHEREAS, store owners along the closed portion of Rizal St. made representations to this Board to reopen said street to vehicular traffic because their business had been prejudiced with the closing of Rizal St. to vehicles;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to repeal as it is hereby repealed, Resolution No. 37, current series, of this Board;

"RESOLVED FINALLY, to furnish copies of this Resolution each the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the Market Superintendent, the City Health Officer and the Chief of Police, all of Ormoc City.
