RESOLUTION NO. 48

"WHEREAS, his death has cut short his plans of making the Philippines a self-sufficient country by his industrialization and agricultural program, by adopting measures to solve the unemployment problem in such a way that there will be harmony between landlords and tenants and capitalists and labor;

"WHEREAS, President Ramon Magsaysay has died a statesman and a friend of all the free loving peoples of the world; and

"WHEREAS, his death has caused grief and sorrows to his immediate and distant relatives;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to express the heartfelt condolences of the Municipal Board of Ormoc City to the bereaved family;

"RESOLVED FINALLY, to furnish copies of this Resolution each the widow of the late President, Mrs. Luz B. Magsaysay, Manila; the City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
