RESOLUTION NO. 50

"WHEREAS, the Provincial Board of Sulu passed Resolution No. 542 on February 26, 1957 requesting the President of the Philippines to act favorably at the earliest time possible on the recommendation of the Three-Men Presidential Committee for the lifting of the exportation ban of commercial and ornamental shells;

"WHEREAS, this Body is of the opinion that with the lifting of the ban on the exportation of commercial and ornamental shells the shell industry in the Philippines will be bolstered and thousands of families throughout the country will be relieved of serious financial and social problems;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Cesar Samson;


