"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere to, as this Body hereby concurs in and adhere to, the embodiments of Resolution No. 262, current series, of the Provincial Board of Pangasinan, and to request further His Excellency, the President of the Philippines, to call at his convenience a convention of provincial Board Members and Members of City Councils and Municipal Board of the Philippines in the City of Manila;

"RESOLVED FINALLY, to forward the original of this Resolution to His Excellency, the President of the Philippines, Malacañang, Manila; and copies be furnished each the Hon. City Mayor, Oroc City, and the Provincial Board, Lingayen, Pangasinan.
