"BE IT RESOLVED, as it is hereby resolved, that this Body give its vote of confidence to Councilors Samson and Larrazabal and consider them as bonafide members of this Board, inasmuch as they were placed here by the electorate of Ormoc in the dections of 1955;

"RESOLVED FINADLY, to furnish copies of this Resolution each to Councilors Samson and Larrazabal, and the Honorable City Mayor, all of Ormoc City.
