RESOLUTION NO. 60

"WHEREAS, Councilor Cesar Samson, in a privileged speech before this Board, manifested that he is relinquishing his chairmanship and memberships of the organized committees of this Board;

"WHEREAS, Councilor Samson further manifested that he is also resigning as Councilor-in-charge of Councilor District No. I which had been assigned to him;

"WHEREAS, these resignations had been voiced by Councilor Samson from his consideration that he is himself a persona non grata to the local faction which helped him win the election last 1955, in view of his adherence and sympathy with the policies of former Mayor Potenciano Larrazabal; and

"WHEREAS, Councilor Alvaro I. Gutierrez countermanifested that Councilor Samson is still a bonafide member of this Board and that his services are still needed by the people;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, that this Body give its vote of confidence to Councilors Samson and Larrazabal and consider them as bonafide members of this Board, inasmuch as they were placed here by the electorate of Ormoc in the elections of 1955;

"RESOLVED FINALLY, to furnish copies of this Resolution each to Councilors Samson and Larrazabal, and the Honorable City Mayor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
