RESOLUTION NO. 62

"WHEREAS, the Bureau of Public Libraries has allotted for  
Ormoc City books, magazines and periodicals for a city library;

"WHEREAS, with the issuance and allotment of these books,  
magazines and periodicals the Bureau of Public Libraries requires  
that a library be established and maintained by the city govern-  
ment;

"WHEREAS, in order to operate a library efficiently the  
city needs a librarian to take charge of the operation thereof;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo  
T. Parrilla, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to create the  
position of Librarian to take charge of the city library;

"BE IT RESOLVED FURTHER, that this position of Librarian as  
is hereby created, be provided for a compensation of P120 per  
month;

"BE IT RESOLVED FURTHERMORE, that the amount of P360.00 be  
as it is hereby, appropriated from out of any funds existing in  
the city treasury not otherwise appropriated, to cover the salary  
of the Librarian from April 1 to June 30, 1957;

"BE IT RESOLVED STILL FURTHERMORE, that this Resolution take  
effect as of April 1st, 1957;

"BE IT RESOLVED FINALLY, to furnish copies of this Resolution  
each to the Director of Public Libraries, Manila; the City Mayor,  
the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
