"BE IT RESOLVED FURTHERMORE, that the amount of \$360.00 be as it is hereby, appropriated from out of any funds existing in the city treasury not otherwise appropriated, to cover the salary of the Librarian from April 1 to June 30, 1957;

MBE IT RESOLVED STILL FURTHERMORE, that this Resolution take effect as of April 1st, 1957;

"BE IT RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Public Libraries, Manila; the City Mayor, the City Treasurer and the City Auditor, all of Ormoc City. "CARRIED UNANIMOUSLY."
