RESOLUTION NO. 63

"WHEREAS, in a letter to this Board dated March 27, 1957, the City Librarian requested an appropriation of P200 for the purchase of office equipments, tables, stalls, book shelves, magazine racks and other equipments necessary for the library;

"WHEREAS, in another letter dated March 28, 1957, the Librarian of the Leyte Branch Library at Tacloban, requested the remittance of P200 to the Bureau of Public Libraries as subscription to periodicals;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the sum of P400 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for expenditures as follows:


P200- to be remitted to the Bureau of Public Libraries as subscription to periodicals;

P200 for the purchase of two long tables, two dozen stalls, two book shelves, magazine racks, sign-board, dater and other equipments for use in the city library;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Public Libraries, Manila; the Librarian, Leyte Branch Library, Tacloban City; the City Mayor, the City Treasurer, the City Auditor and the City Librarian, all of Ormoc City.

"CARRIED UNANIMOUSLY."


