RESOLUTION NO. 66

"WHEREAS, Lots Numbers 23 and 93 of the cadastral survey of Ormoc have already been reserved in a previous resolution of this Board for the construction of a gymnasium;

"WHEREAS, the City Engineer in a communication to this Board is requesting for a lease of these two lots in order that the city can receive as early as possible the equipments and tools allocated for the motor pool of the city engineering department and which will be sent immediately by the Bureau of Public Highways upon receipt of the lease contract;

"WHEREAS, for the present the city is not yet in a position to construct a gymnasium; and

"WHEREAS, in order to avail of the opportunity to receive tools and equipments for the engineering department, this Body deems it wiser to repeal the previous resolution reserving said lots as gymnasium site, and leasing the same to the engineering department, this city;


"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to repeal the previous resolution of this Board, reserving lots Nos. 23 and 93 as gymnasium site;

"CARRIED. Five affirmative votes, one negative vote."


