RESOLUTION NO. 67

Letter of the City Engineer, Ormoc City, dated March 11,  
1957, addressed to this Body, quoted verbatim hereunder, follows:

Gentlemen:

I have the honor to furnish herewith true copies of the  
Memorandum of the Division Engineer dated March 2, 1957 for your  
information and guidance.

In this connection, I have the honor to request that body  
to pass a resolution granting a permanent lease for lots Nos. 23  
and 93 of the cadastral survey of Ormoc to the Bureau of Public  
Highways for use of the Engineering Department, Ormoc City. The  
said lots are the present site of the existing Bureau of Public  
Highways Shop and Yard, City Engineer's Administration building  
and Bureau of Public Works Warehouse.

It is informed further that should this Office fail to  
comply with all the requirements, it would mean to forfeit all  
the ICA shop tools and equipment which are allocated to our motor  
pool. As it is now, the present motor pool site has already an  
approved plan and only slight modifications of the existing  
buildings in the shop shall establish it in conformity with the  
said approved plan. Moreover, to transfer then the present loca-  
tion to another site, would incur great expenses aside from the  
delay which might not cope with the time limit.

"WHEREAS, because of the urgency of receiving the equipment and tools mentioned above under a time limit and considering that leasing lots numbers 23 and 93 to the city engineering department in order to receive said equipment and tools would be to the best interest of the city government,

"THE BOARD, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Cubillo;


"BE IT RESOLVED, as it is hereby resolved, to lease permanently Lot Nos. 23 and 93 of the Cadastral Survey of Ormoc, to the Engineering Department, Ormoc City, on the following conditions:

1. That the Engineering Department pay to the city government a nominal rental of ONE PESO (P1.00) per annum during the whole period of lease;
2. That this lease is granted on the condition that the promised equipment and tools be delivered to the Engineering department, Ormoc City, immediately after receipt by the Bureau of Public Highways the contract of lease;
3. That this lease is not subject to any sub-lease without the consent of the city government of Ormoc; and
4. That in the event that these lots would no longer be used for the purpose for which they are leased, the same should revert automatically to the city government of Ormoc.


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director/Commissioner of Public Highways, Manila; the City Mayor, the City Engineer, the City Treasurer and the City Auditor, all of Ormoc City; and the Highway Division Engineer, Cebu City.

"CARRIED. Five affirmative votes, one negative vote."


