RESOLUTION NO. 70

"WHEREAS, in sympathy over the death of the late President Magsaysay, former City Mayor Potenciano Larrazabal ordered his Secretary to secure a black coco cloth to be used as drape of the city hall to signify the city's mourning of the demise of the late President Magsaysay;

"WHEREAS, former Technical Assistant to the City Mayor, Atty. Artemio T. Derecho acting on the directive of the City Mayor to secure a black cloth, purchased on account from the Nestor Bazar 14 meters of black coco cloth and which was used as drape of the city hall;

"WHEREAS, the owner of the Nestor Bazar is demanding payment of the said black coco cloth; and

"WHEREAS, the Honorable City Mayor in a 1st indorsement to this Board dated April 13, 1957, suggested that this amount may be taken from his discretionary fund;


"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of ₱14.00 from out of the discretionary fund of the City Mayor, to be made available for the payment of 14 meters of black coco cloth in favor of Nestor Bazar, used by the city as above mentioned;


"RESOLVED FINALLY, to furnish copies of this Resolution each the Honorable City Mayor, the City Treasurer, the City Auditor and Nestor Bazar, all of Ormoc City.

"CARRIED UNANIMOUSLY."


