RESOLUTION NO. 71

Letter of the City Supervisor, Ormoc City District I, dated
April 13, 1957, addressed to this Board, quoted verbatim hereunder
follows:

Gentlemen:

I am sending you the payroll for the one month unpaid salaries of the intermediate teachers of this District and earnestly request the help of that Body so that the same can be paid as early as possible. The intermediate teachers in this District need this money very badly as many of them are attending summer classes. I am sending this payroll to you inspired by the talk I had with the new Mayor, His Honor, Esteban Conejos who promised that he would attend to this matter with interest and consideration. Thanking you for your kind attention and assuring you of the teachers' and my deep appreciation for your help.

"WHEREAS, the City Treasurer, in his letter to this Board dated April 13, 1957, signified his willingness to pay the salaries of the intermediate teachers, subject matter of the above-quoted letter of the City Supervisor, provided that the vacation salary of the new Intermediate Teachers will be included in the next fiscal year annual budget (1957-1958) for Intermediate

Schools as outstanding obligation; and

"WHEREAS, in view of the willingness of the City Treasurer to pay said payroll of the intermediate teachers and considering that this is an obligation of the city government to the intermediate teachers, which obligation was incurred sometime in 1954;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;


"BE IT RESOLVED, as it is hereby resolved, to authorize the City Treasurer, Ormoc City, to pay the back salaries of the intermediate teachers (Districts I & II) for the month of June, 1954; .

"RESOLVED FURTHER, that this amount which may be paid to the intermediate teachers, be obligated in the coming budget of Ormoc City, for the fiscal year 1957-1958;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisors of Ormoc City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


