RESOLUTION NO. 72

"WHEREAS, Lot No. 2255 of the Cadastral Survey of Ormoc has been declared public land by default on May 3, 1935;

"WHEREAS, the same lot above mentioned has been reserved by the city government of Ormoc for future public improvement and for playground under Resolution No. 76, s. 1955 and Resolution No. 86, s. 1951;

"WHEREAS, before said lot was declared public land on May 3, 1935, one, Vicente Bañez, now deceased, owned a portion of the same bordering the Anilao River, which later on was washed away by floods and thereby, the late Vicente Bañez was no longer interested in his lot so that during the hearing of the Cadastral Court no one claimed the lot - thus the Court declared the same a public land;

"WHEREAS, at present, nobody is actually occupying said lot;

"WHEREAS, Atty. Bienvenido Bañez, the son of the late Vicente Bañez, made representations to this Board requesting that he be granted the right to apply for a revocable permit on the same lot formerly owned by his father, a portion of Lot No. 2255 which has been reserved by this Board as playground and for future public improvement in Resolution No. 76, s. 1955 and Resolution No. 86, s. 1951;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to grant Atty. Bienvenido Bañez, the right to apply for a revocable permit on a portion of Lot No. 2255, bordering the Anilao River, which portion consisting of 1,300 square meters;

"RESOLVED FINALLY, to furnish copies of this Resolution each the Director of Lands, Manila; the District Land Officer, Tacloban; the Honorable City Mayor, the City Engineer and Atty. Bienvenido Bañez, all of Ormoc City.

"CARRIED UNANIMOUSLY."
