RESOLUTION NO. 73

Letter of the City Health Officer, Ormoc City, dated April 6,
1957, quoted verbatim hereunder, follows:

Sirs:

Respectfully request from the Honorable Municipal Board the
appropriation of P500.00 to be used for the salary of another sani-
itary inspector who will take the place of Antonio Esmero who is
going to retire and will take his terminal leave with pay for 7 months
and 9 days. This is necessary in order not to interrupt the servi-
ces of another sanitary inspector.

It is hoped that that Honorable Body will favorably consider
this request so that services of the Sanitary Inspector at Bo. Bolo-
res where Antonio Esmero is assigned will not be hampered.

"BE IT RESOLVED, as it is hereby resolved, to revert the amount of P500.00 from out of the unexpended balance on the P10,000 appropriated for the purchase of the City Mayor's car, to be made available for the salary of a Sanitary Inspector to take the place of Antonio Esmero;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City.
