Sirs:

Respectfully request from the Honorable Municipal Board the appropriation of \$\mathbb{P}500.00\$ to be used for the salary of another sanitary inspector who will take the place of Antonio Esmero who is going to retire and will take his terminal leave with pay for 7 months and 9 days. This is necessary in order not to interrupt the services of another sanitary inspector.

It is hoped that that Honorable Body will favorably consder this request so that services of the Sanitary Inspector at Bo. Bolores where Antonio Esmero is assigned will not be hampered.

"BE IT RESOLVED, as it is hereby resolved, to revert the amount of \$\mathbb{P}\$500.00 from out of the unexpended balance on the \$\mathbb{P}\$10,000 appropriated for the purchase of the City Mayor's car, to be made available for the salary of a Sanitary Inspector to take the place of Antonio Esmero;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditorand the City Health Officer, all of Ormoc City.
