RESOLUTION NO. 74

"WHEREAS, this Board, sometime in January, 1956, created the position of Janitor at Valencia Central School, District II, Ormoc City;

"WHEREAS, the position of Janitor as created by this Board was filled in last February 1, 1956 by Pedro A. Codilla;

"WHEREAS, this Board came to know that up to the present, Mr. Pedro A. Codilla has not been paid of his salaries since February 1, 1956, as Janitor at Valencia Central School;

"WHEREAS, this Board was also informed that the cause in the delay of the payment of his salaries is that until now the Division Superintendent of Schools has not signed the appointment of Mr. Pedro A. Codilla as janitor of said school;

"WHEREAS, the City Treasurer is willing to pay the salaries of Mr. Pedro A. Codilla anytime if he can produce an appointment from the Division Superintendent of Schools;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the Division Superintendent of Schools, Tacloban City, to approve an appointment in favor of Mr. Pedro A. Codilla, as Janitor of Valencia Central School, Ormoc City, so that he can collect his salaries which has long been delayed because of this requisite;

"RESOLVED FURTHER, to authorize the City Treasurer, Ormoc City, to incorporate in a supplemental budget, the amount covering the salaries of Mr. Pedro A. Codilla since February 1, 1956;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the District-Supervisor, Ormoc II; the Honorable City Mayor, the City Treasurer, the City Auditor, and Mr. Pedro A. Codilla, all of Ormoc City.

"CARRIED UNANIMOUSLY."
