RESOLUTION NO. 77

"WHEREAS, a loan in the amount of P100,000 for the construction of additional market buildings in Ormoc City has been approved recently by the Rehabilitation Finance Corporation;

"WHEREAS, at present said market buildings are under construction;

"WHEREAS, in view of the numerous prospective applicants for market stalls in the market which is about to be finished, this Board has foreseen the congestion of tiendas in the market; and

"WHEREAS, in order to solve this congestion this Board has planned to construct another market in the poblacion; and

"WHEREAS, Valencia is one barrio in Ormoc which needs a public market;


"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilors Alvaro I. Gutierrez and Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the Rehabilitation Finance Corporation, Manila, to grant another loan of P100,000 for the construction of Market No. 2 in Ormoc City, and another P25,000 for the market in Barrio Valencia;


"RESOLVED FINALLY, to forward the original of this Resolution to the RFC, Manila; and copies furnished each the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


