RESOLUTION NO. 79

"WHEREAS, the position of Chief of the Fire Department is one which needs an occupant who is physically sound, possibly not old enough as to render him inefficient and unfit to the service;

"WHEREAS, the present incumbent is over aged and this Board doubts his efficiency and usefulness to the service;

"WHEPEAS, this Board knows of a former army man, Major Teofilo Moncada who is much younger and abled than the present Fire Chief, and who this Board believes is more gualified to serve as Fire Chief than the protent incumbent; and

WEREAS, in the interest of the service, this Board recommends Major Tooklo Moncada as Chief of the Fire Department of Ormoc City to relieve the present incumbent;

"NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Teotimo Pa Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia, to consider the name of Maj. Teofilo Moncada as a prospective Chief of the Fire Department of Ormoc City, considering that the present Fire Chief is over aged and therefore, renders him physically unfit for the service;

"RESOLVED FINALLY, to forward the original of this Resolution to His Excellency, President Carlos P. Garcia, Malacañang, Manila; and a copy be furnished to His Honor, the City Mayor, Ormoc City. "CARRIED UNANIMOUSLY."
