RESOLUTION NO. 81

"WHEREAS, a letter from the Division Superintendent of Schools, Tacloban City, has been indorsed to this Board by the District Supervisor in charge of the City High School at Ormoc City, giving notice to the city that unless Ormoc City can provide an adequate site of at least eight hectares for the Ormoc City High School, his office (the Division Superintendent's) will be constrained to close the Ormoc City High School;

"WHEREAS, at present Ormoc City is not in a position to purchase eight hectares for the school site of the City High School;

"WHEREAS, this Board fears that with the city's failure to comply with this requisite of the Division Superintendent the City High School will be closed, thereby depriving school children of high school age not only in Ormoc City but also those from the neighboring towns, of public school education; and

"WHEREAS, in order to solve this problem this Board has thought of requesting the President of the Philippines for an aid from either his discretionary or contingent fund with which to purchase a site for the City High School of Ormoc as required by the Division Superintendent of Schools;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia, to give an aid to Ormoc City from either his discretionary or contingent fund in the amount of ₱20,000 for the purchase of a site for the Ormoc City High School;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, President Carlos P. Garcia, Malacañang, Manila; the Secretary of Education, Manila; the Director of Public Schools, Manila; the Division Superintendent of Schools, Tacloban City; the Principal, City High School and His Honor, the City Mayor, Ormoc City.




