"WHEREAS, Mr. Flaviano Maglasang, proprietor of the Ormoc Press is making representations for the payment of P25.00;


"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo P. Ocubillo;
