RESOLUTION NO. 35

"WHEREAS, the Barrio Lieutenant of Liloan manifested before this Board that one of the greatest problems of agriculture in his barrio is fertilizer;

"WHEREAS, according to said Barrio Lieutenant the produce of many farmers in his barrio are gradually reducing every year because of lack of fertilizer;

"WHEREAS, said Barrio Lieutenant, speaking in behalf of the hundreds of farmers in Barrio Liloan requested this Board to negotiate with the Bureau of Agricultural Extension Office in Tacloban for any aid that may be extended to his farmers in order to solve such a grave problem of agriculture; and

"WHEREAS, Councilor Jorge P. Tan, Jr., this Board's Chairman on the Committee of Agriculture, manifested that he will make representations with the Office of Agricultural Extension in Tacloban with the end in view of requesting the authorities concerned for the aid needed by the Barrio people of Liloan;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo P. Ocubillo;


"BE IT RESOLVED, as it is hereby resolved, to authorize as this Body hereby authorizes, Councilor Jorge P. Tan, Jr., this Board's Chairman on the Committee on Agriculture, to make representations with the Bureau of Agricultural Extension Office in Tacloban with the end in view to request aid on anything, acting on the request of the barrio people of Liloan, Ormoc City;



"CARRIED UNANIMOUSLY."


