RESOLUTION NO. 87

"WHEREAS, Vice Mayor Rafael M. Mejia presented before this Board vouchers covering reimbursement of actual and necessary expenses in his official travels to Manila, amounting to P829.20;

"WHEREAS, according to the City Treasurer the travels of Vice Mayor Mejia above mentioned could not be paid from the present appropriations of traveling expenses inasmuch as they have been made in the years 1955 and '56, without the express authority of this Board to that effect;

"WHEREAS, this Board sees that Vice Mayor Mejia is rightfully and legally entitled to collect reimbursement for his expenses on his official travels;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to obligate and certify as an outstanding obligation the amount of P829.20, representing reimbursement of traveling expenses of Vice Mayor Mejia, and to incorporate the same in the coming budget of Ormoc City for the fiscal year 1957-58, without prejudice to advancing the sum of P500.00 from the current general fund now available, and hereby authorizing the City Treasurer to pay Vice Mayor Mejia the said sum of P500.00;


