RESOLUTION NO. 38

"WHEREAS, when the present vicinal road from Valencia to Maticaa was not yet constructed, it was proposed in the plan that the road take its course along the border of Lot No. 8643, owned by Mr. Julian Gantuango, taking along its course a portion of said lot, and which Mr. Gantuango is willing to donate;

"WHEREAS, when the road was constructed its proposed course was not followed, so that instead of following the border of Lot No. 8643, it traversed said lot, thereby abandoning the proposed course which Mr. Gantuango has already donated;

"WHEREAS, Mr. Gantuango is making representations with this Board for the purpose of recovering or recalling his previous donation and exchanging the same with the one now occupied by the vicinal road above mentioned; and

"WHEREAS, this Board sees that his offer is good and in order and considering also his rights as a citizen and private property owner;


"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;




